The Barnet (Free Parking Places, Loading Places, Waiting, Loading and Stopping Restrictions) (Amendment No.22) Order 2016

Made: 13th October 2016

Coming into operation: 17th October 2016

The Council of the London Borough of Barnet, having consulted the Commissioner of Police of the Metropolis, in exercise of the powers conferred by sections 6 and 124 of and Schedule 9 to the Road Traffic Regulation Act 1984(a) and of all other powers thereunto enabling, hereby make the following Order:-

1. Citation and commencement

- 1.1 This Order shall come into operation on 13th October 2016 and may be cited as The Barnet (Free Parking Places, Loading Places, Waiting, Loading and Stopping Restrictions) (Amendment No.22) Order 2016

2. Interpretation

- 2.1 In this Order “the Order of 2014” means The Barnet (Free Parking Places, Loading Places and Waiting Loading and Stopping Restrictions) Consolidation Order 2014(b)
- 2.2 Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.


3. Substitution of Map Tiles

- 3.1 Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, the Order of 2014 shall have effect as though for the map tile attached to that Order and specified in column 1 of Schedule 1 to this Order, there were substituted the map tile attached to this Order and specified in relation thereto in column 2 of Schedule 1 to this Order.
- 3.2 The substitution of any map tile referred to in Article 3.1 of this Order will have the effect of revoking any provision provided or designated by a previous version of that map tile and not incorporated into the latest version.

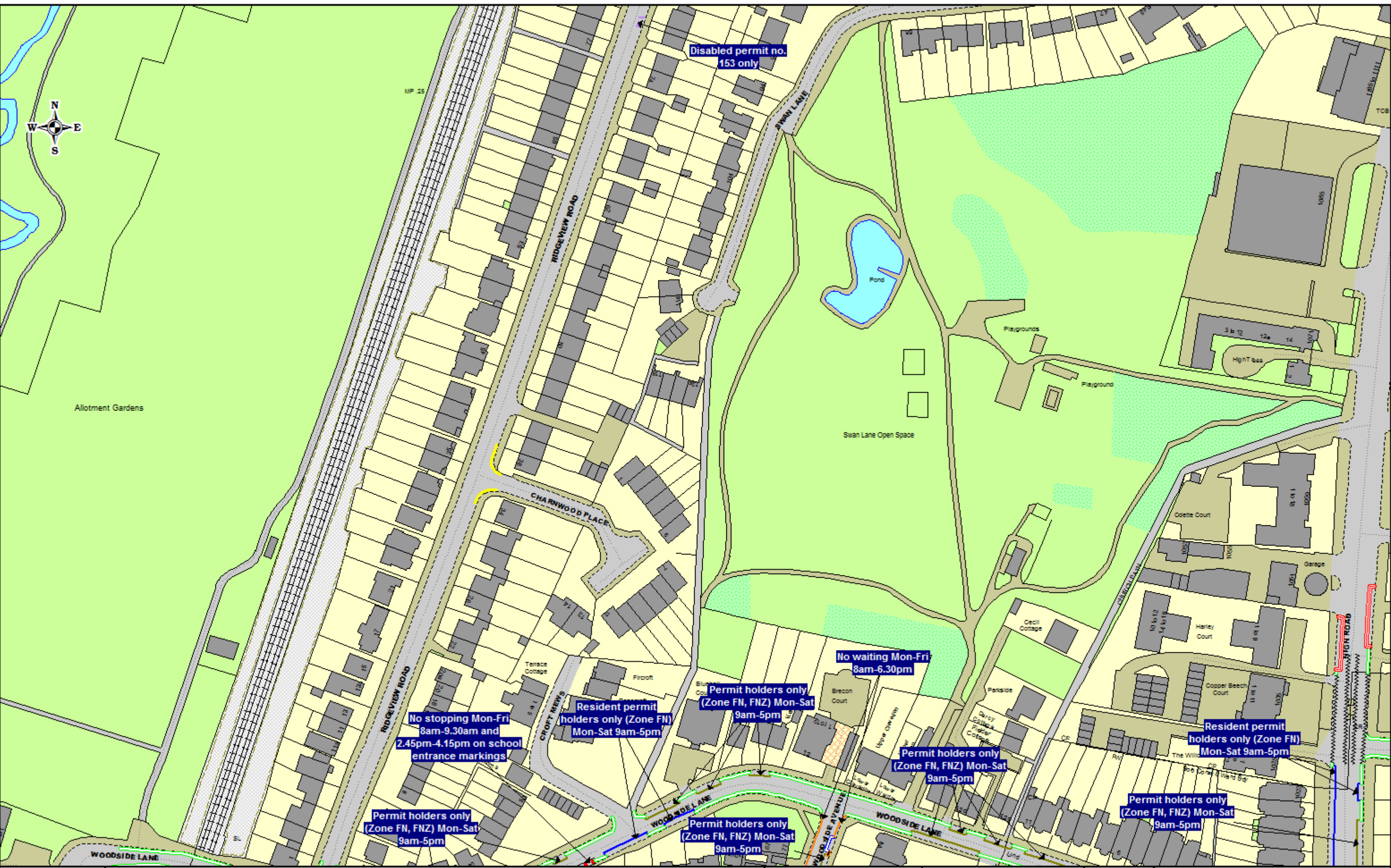

STATEMENT OF REASONS

The above Order relate to a disabled bay as detailed below.

In order to provide a parking facility to a disabled blue badge holder who meet qualifying criteria, the general effect of the above Order will be to provide a designated disabled parking bay for use by a motorist in their vehicle who displays both a valid disabled blue badge and a dedicated disabled permit which will be applicable to the dedicated disabled bay outside No.78 Ridgeview Road N20.
