

THE HISTORIC BUILDINGS OF THE LONDON BOROUGH

This row of almshouses listed under the Town and Country Planning Act 1962 because of their architectural and historic interest, was built by Lawrence Campe, a City of London draper, in 1612. By indenture, he gave the seven poor occupants 12 pence a month each in perpetuity, and 4 shillings a year to the church wardens of St. James's to manage the charity, with an additional sum of £1 6s. 8d. a year to keep the houses in repair. The whole amount was provided from a rent charge on an estate in Hertfordshire.

The two-storey houses are of stonedressed red brick in the Late Perpendicular or Tudor style. They were renovated in 1843 and largely rebuilt in 1899 to celebrate Queen Victoria's Jubilee. The arms of the City of London and the Drapers Company are carved on stone plaques along the first floor.

THE NEW MAYOR

Councillor Usher is married, with a son and two daughters, and has lived in Finchley since he moved with his family in 1927. In addition to his being a director of W. P. Usher Ltd. contractors to the timber trade— Councillor Usher farms at South Woodham Ferrers and is also a garage proprietor.

MEMBERS OF THE COUNCIL



Alderman Stanley Head Chairman of the Establishment Committee

Alderman Stanley Head is a Londoner by birth, although he spent his early years in the West Country, where he was educated at the Kings School, Bruton, Somerset, and afterwards served his Articles with a firm of Solicitors in Exeter, Devon.

He has been a resident of the East Barnet District since 1931.

During the last war he served in the Royal Artillery and at the end of the war he was a Staff Officer, with rank of Major at the Headquarters of 30 Corps, then commanded by Sir Brian Horrocks.

He is a Solicitor in private practice and also a Notary Public.

First elected to the former East Barnet Urban District Council in 1947 he served continuously as a Member until the District became part of the London Borough in 1965.

He served on all the various Committees of the Urban District Council and was for a number of years Chairman of its Finance Committee. He occupied the Office of Chairman of the Council for the Municipal Year 1955/56.

On the formation of the London Borough he was elected one of the first Aldermen, for a six year period.

Alderman Stanley Head is now Chairman of the Establishment Committee and Vice-Chairman of the Public Works Committee. He also serves on the Finance, General Purposes and Policy Advisory Committees and the Northern Area Road Safety Committee.

He was Deputy Mayor for the Municipal Year 1966/67.

He has always taken a keen interest in Educational Affairs and was for many years a member of the South Herts Divisional Executive for Education. He is now Chairman of the Governors of East Barnet Grammar School and is a Governor of the Queen Elizabeth Grammar and Elizabeth Allen Church of England Schools.

He is Chairman of Group II Primary School Managers, comprising Littlegrove, St. Margarets, Livingstone, Oaklands and Cromer Road Schools and Brookhill Nursery School.

For seven years Alderman Stanley Head was the Chairman of the Barnet Division Conservative Association, of which he has now been President for a number of years. Amongst his other interests he is Chairman of the East Barnet Citizens' Advice Bureau, Vice-President and Honorary Solicitor to the East Barnet Branch of the British Legion and Vice-President of the East Barnet Old People's Welfare Association and Vice-President of the East Barnet National Savings Association.

At one time a keen Lawn Tennis player, he was one of those responsible for the formation of the Gloucester Lawn Tennis Club, New Barnet, and was the Chairman of the Club in its early years.

HENDON CREMATORIUM

Between the hours of 11 a.m. and 4 p.m. on Sunday, 27th April, 1969, Hendon Crematorium was made available for inspection by the general public during which time some 400 visitors took advantage of this facility.

It is interesting to note that although only approximately 450 cremations took place at Hendon during the years of 1962, 1963 and 1964, a total of 980 cremations took place during 1968, and it was in order to further encourage this trend that the Crematorium was made available for public inspection.


Normally the Crematorium and Cemetery Office is open between the hours of 9 a.m. and 5 p.m. Monday to Friday only but the office remained open between the above mentioned inspection hours on this particular occasion in order that any information could be provided to visitors. Staff were on duty throughout the period and were posted at strategic points on the driveways in order to direct visitors to the Car Park which surrounds the Crematorium proper whereat the operational staff were available to give full explanations in answer to any enquiries put to them by visitors.

The arrival of visitors was spaced extremely evenly over the five hours' inspection period hence at no time were the staff under pressure to advise visitors in a hurried manner and from the various expressions of approval made there is little doubt that this venture was a success. Certainly from the aspect of alleviating the aura of suspicion which unjustifiably surrounds cremation this media of enlightening the general public in respect of the completely ethical manner in which cremation work is carried out could well be followed by the many other Crematoria throughout our Country.

The municipal crematorium at Holders Hill Road, Mill Hill, will be OPEN FOR INSPECTION by the public on Sunday, 14th September, 1969, between the hours of 11.00 a.m. and 6.30 p.m. Car parking space is available.

PUBLIC CONTROL SECTION


A new section of the Town Clerk's Department—the Public Control Section—came into operation on 1st April, 1969. The Section, which is located at the Weights and Measures Office in The Burroughs, N.W.4., offers protection to consumers by means of a small group of specialist inspectors who visit trade premises under the Weights and Measures Act and keep a watchful eye for false trade descriptions applied to goods and services as well as misleading price indications, all of which are forbidden by the new Trade Descriptions Act.

The safety of the public is also part of the section's job; heavy lorries passing through the borough are stopped and weighed to make sure they are not overloaded and local motorists will be able to have their tyre pressure gauges tested free of charge by calling at the Weights and Measures Office. Most local garages already take part in the voluntary scheme to have their tyre gauges tested when the inspectors of weights and measures call to test their petrol pumps. The inspectors also examine oil heaters, fireguards and nightdresses for safety, and children's toys will be tested to make sure the paint does not contain lead.

The section also issues licences under various statutes and visits are made to ensure that licensing conditions are being observed relating to the conduct of employment agencies, and the storage of poisons and fireworks by traders.

The Shops Acts inspectorate, previously at Green Shield House, Edgware, now form part of the new section operating from the Weights and Measures Office.


The Council has decided to operate a Consumer Protection Service as part of the new Section for the purpose of investigating complaints in respect of the supply of faulty goods and unsatisfactory services made by local residents, or against local traders by any person. The service is intended to bridge the gap between the protection given to consumers by statute law and the useful advisory services provided by such organisations as the Citizens' Advice Bureaux.

The Council believe that the new Consumer Protection Service will be useful in enabling residents who have bought goods which prove to be faulty or who have had services badly executed, to have their complaint impartially investigated by an officer who will try to negotiate a satisfactory settlement with the trader. Complaints will only be accepted at the Weights and Measures Office after the complainant has first attempted to settle the matter privately with the trader concerned. The Council will not of course be able to initiate legal proceedings on behalf of complainants.

It is expected that the Consumer

Protection Service will be of benefit to traders and consumers alike and it is hoped to secure the co-operation of Chambers of Commerce, local Consumer Groups and Citizens' Advice Bureaux in its operation.

Complaints and enquiries will be received either in writing or by personal visit at the Weights and Measures Office where they will be dealt with by the Public Control Officer, Mr. E. Roche, and the staff of the section.

MEMBERSOF THE COUNCIL



Alderman L. A. Hills Chairman of the Housing Committee

Alderman Hills has been a resident of Hendon for nearly forty years and first represented Central Ward-now Hendon Ward—some twenty years ago. He has been, and still is, a member of the Hendon South Conservative Association Divisional and Ward Committees.

He was elected a Councillor for the former Borough of Hendon in 1949, appointed an Alderman in 1960, and became Mayor of that Borough in 1960/61.


He served on most of the main Committees of the former Borough Council, and was Chairman of the Housing, Highways and Finance Committees of that authority.

On the formation of the London Borough of Barnet, Alderman Hills became its first Chairman. He is at present Chairman of the Housing Committee, he has also been Chairman of the Finance Committee and serves on the Establishment, Finance, Grahame Park & Burnt Oak Developments, Housing, Policy Advisory and West Hendon Development Committees, in addition to the Council and Staff Joint Sub-Committee, the London Borough of Barnet Whitley Works Joint Sub-Committee, the Budgetary Control Sub-Committee, and he also acts as a substitute for the Chairman or Vice-Chairman of the Finance Committee with regard to applications for Housing Act Advances.

He is a member of the Metropolitan Water Board and has been so for eight years. During this time he served on most of the main Committees and has been Chairman of its Assessment and Claims Committee and is now Vice-Chairman of the General Purposes Committee. COUNCIL HOUSING — PROGRESS REPORT

The Borough Architect's progress report, submitted to the Council's Housing Committee held on 31st March, 1969, indicated that contracts in hand, and accepted tenders would provide 1326 additional dwellings by mid-1970.

Of this number, 135 have now been completed at Stone Grove, 24 at Russell Lane and 36 at Kingsbury Road.

The development of the Dollis Valley Estate will also provide 636 units. the completion of which is phased during the next 12 months.

Within the current provision, accommodation will shortly be ready for occupation at:-

East Crescent (30 units) Russell Lane (balance 24 units) The Avenue (91 units) The Homestead (63 units)

Alderman Hills is also a member of the Employers Side of the Greater London Joint Council for Local Authority Services (Manual Workers) and serves on the Works Committee of the London Boroughs Association, in addition to his membership of the London Boroughs Management Services Committee. For two years he was Chairman of the Trustee Savings Bank Group B N.W. Committee of which he is still a member.

Drains-do not obstruct the access

At a recent meeting of the Council's Health and Welfare Committee the Medical Officer of Health reported two contraventions under Section 41 of the Middlesex County Council Act 1956, in that concrete drive-ins on private properties had subsequently been laid over inspection chambers.

A p a r t from the considerable nuisance to the householders concerned any obstruction of access to a manhole or inspection chamber is a punishable offence under the above-mentioned Act.

Rating of Empty Properties

The Barnet London Borough Council adopted the provisions of Section 17 and Schedule 1 of the General Rate Act, 1967, as from April 1st, 1968.

- As from that date therefore-
- (i) all newly erected dwelling houses or flats remaining unoccupied after an initial period of six months and
- (ii) all other dwelling houses, flats and other types of property remaining unoccupied, after an initial period of three months will be liable to be rated.

The liability for payment of rates on empty property will fall on the "owner", i.e. the person entitled to possession.

One half of the full rate will be payable and in the case of domestic

In the following circumstances unoccupied property will not be liable to be rated for any period during which:

 (a) The owner is entitled to possession of the hereditament only in his capacity as the personal representative of a deceased person;

- (b) There subsists in respect of the owner's estate a receiving order made under the Bankruptcy Act, 1914;
- (c) The owner is entitled to possession of the hereditament in his capacity as trustee under a deed of arrangement to which *continued on page 8 column 3*

IMPERSONATION OF COUNCIL OFFICERS

In view of the number of frauds committed by persons posing as Local Government or Public Officers, members of the public should note that each Officer of the Barnet London Borough Council who is authorised to make calls or inspect premises within the London Borough, carries a card of authorisation and identification, which is signed by the person concerned and by the Town Clerk. The card also bears a photograph of the Officer in question.

You are advised, therefore, to refuse admittance to your home to any person unable to produce this authority, and immediately to report the matter to the Police.

If you are still suspicious, upon production of an identity card, you are advised to refuse admission and either—

- 1. Ring the Town Hall, Hendon— 202 8282, extension 19, quoting the number on the card, when the other particulars can be verified, or
- 2. Require that a request be made in writing for admittance to the property, stating the reasons for which entry is required.

the Deeds of Arrangement Act, 1914, applies;

- (d) The owner is a company which is subject to a winding up order made under the Companies Act, 1948;
- (e) The owner is a company which is being wound up voluntarily under the Companies Act, 1948;
- (f) The owner is entitled to possession of the hereditament in his capacity as liquidator by virtue of an order made under Section 244 or 307 of the Companies Act, 1948;
- (g) The owner is prohibited by law or public action from occupation;
- (h) The hereditament is subject to a Building Preservation Order or an Order under the Ancient Monuments Acts or is a Building of architectural or historic interest;
- (i) The hereditament is held for occupation by a Minister of Religion from which to perform his duties.
