- 1. The enlargement, improvement or other alteration of a dwellinghouse (as ascertained by external measurement) is not exceeded by more than 1,750 cubic feet or \$\frac{1}{10}\$th whichever is the greater, subject to a maximum of 4,000 cubic feet; provided that the erection of a garage, stable, loosebox or coach-house within the curtilage of the dwelling-house shall be treated as the enlargement of the dwellinghouse for the purpose of this permission.
- 2. The erection, construction or placing and the maintenance improvement or alteration, within the curtilage of a dwellinghouse, or any building or enclosure (other than a dwelling, garage, stable, loosebox or coach house) required for a purpose incidental to the enjoyment of the dwellinghouse as such, including the keeping of poultry, bees, pet animals, birds or other livestock for the domestic needs or personal enjoyment of the occupants of the dwellinghouse.

- 4. The construction within the curtilage of dwellinghouse of a hard-standing for vehicles for a purpose incidental to the enjoyment of the dwellinghouse as such.
- 5. The erection or placing within the curtilage of a dwellinghouse of a tank for the storage of oil for domestic heating so long as:
  - a. the capacity of the tank does not exceed 3,500 litres;





# DIRECTION MADE UNDER ARTICLE 4(1) TO WHICH ARTICLE 6 APPLIES

WHEREAS London Borough of Barnet being the appropriate local planning authority within the meaning of Article 4(4) of the Town and Country Planning (General Permitted Development) Order 1995, are satisfied that it is expedient that development of the descriptions set out in the schedule below should not be carried out at specific residential properties in the **Hampstead Garden Suburb Conservation Area**, being more particularly the areas coloured blue and yellow on the attached map, unless permission is granted on an application made under Part III of the Town and Country Planning Act 1990.

It should be noted that within Spaniards End, only Part 2 Class A will be applied.

NOW THEREFORE the said Council in pursuance of the power conferred on them by Article 4(1) of the Town and Country Planning (General Permitted Development) Order 1995 hereby direct that the permission granted by Article 3 of the said Order shall not apply to development on the said land of descriptions set out in the Schedule below.
